**SUBJECT**: Share buyback

DATE: December 19, 2025

The Board of Directors of Grupo Nutresa S.A. has approved, as of this date, the General Regulations for the Buyback of Company Shares, within the framework of the Share Buyback Program approved by the Shareholders' Assembly today, December 19, 2025.

The regulations approved by the Board of Directors provide, among other matters, that the Company may acquire up to 10,000,000 shares at a price of three hundred thousand pesos (\$300,000) per share, through the formulation of one or more buyback offers during the years 2026, 2027, and 2028.
